WHEREAS, the party of the second part is a non-profit corporation organized and incorporated under the laws of the State of Maryland for the purpose of enhancing, protecting and advancing the rights and welfare of the owners of property in the subdivision known as MANHATTAN BEACH in Anne Arundel County, Maryland.

WHEREAS, the parties of the first part, now being vested with title to the property hereinafter described, subject to the rights of the owners of property in MANHATTAN BEACH to use the same in common, desire to convey said property to the party of the second part to hold the same for the proper use and benefit of said property owners.

WITNESSETH, that in consideration of the mutual promises of both parties (the actual cash consideration being -\$0-), the said Henry M. Bachman and Rose Mellor Bachman Baker do grant and convey unto the said Manhattan Beach Civic Association, Inc., its heirs and assigns, in fee simple, all those lots of ground situate, lying and being in the Third District of Anne Arundel County, aforesaid, and described as follows, that is to say:
