Dear Property Owners,

This letter is being sent to you because you own property in the Manhattan Beach subdivision. As a resident, you have access to certain rights-of-way owned by the MBCA. A copy of a map of Manhattan Beach depicting the land owned by MBCA and the rights-of-way is attached to this letter.

You may have used some of these MBCA rights-of-way during your time in the Community. This use has been with MBCA’s permission. A letter noting that permissive use was previously tendered to all property owners on October 1, 2002. By this letter, MBCA is reaffirming its position and writing to formally advise that community members’ use of MBCA’s rights-of-way is done with MBCA’s consent. Please also be advised that along with this consent, you may not extend, enlarge, or otherwise expand your use of MBCA’s rights-of-way. Further, the MBCA grants to the addressee of this letter a license, revocable at will by the MBCA, at its sole discretion, to permit the use of MBCA’s rights-of-way on these terms.




