## Sonneborn Subdivision

April 2003 brings us just short of two years since Manhattan Beach began its fight against the proposed single-family detached condominium subdivision at the entrance to Manhattan Beach. Although there have been a few changes in the sketch plans submitted to the County by the developer, Mandrin Construction Co., the basic issues have remained the same.

The entire Sonneborn property is zoned R2, which under Anne Arundel County zoning code is restricted to a gross density of 2.5 homes per acre on 15,000 square foot lots. Lots of 10,000 square feet are permitted if the developer applies for Cluster development and trades off the 5,000 square foot difference to undisturbed open space for use by all homeowners in the subdivision.

Mandrin has not applied for either of these permitted uses and claims that as he proposes to build under a condominium regime there is only a single lot under common ownership of all purchasers and there are no internal lots that have to obey lot sizes stipulated in the County zoning codes. Unfortunately, the Anne Arundel County Office of Law has delivered a legal opinion that sides with Mandrin (and seven other builders waiting in the wing who want to do the same thing) claiming that since there are no internal lots, there are no specified lot sizes or building set backs that must be followed.

This opinion effectively means that lot sizes will be determined exclusively by those developing properties under a condominium regime. The Mandrin Construction plan calls for as many as six units in a single acre in at least one instance with lot sizes as small as 4,500 square feet.

The opinion makes mockery of Anne Arundel County subdivision and zoning codes as well as the provisions of the Maryland Condominium Act. Not only does Anne Arundel County Code clearly specify lot sizes as described in the second paragraph above, but it also states that there can be only one principal structure on a single lot. Furthermore, the County Code for both zoning and subdivisions states that where there is ambiguity or conflict in the code, the stricter provision in the code applies. On top of all this are the provisions of the Maryland Condominium Act that make it clear that:

- 1.) A condominium regime is a form of property ownership and not a form of land use.
- 2.) Condominium regimes must obey all local building and zoning codes to the same extent that they apply to all other forms of development of the property.

The Sonneborn Subdivision issue has been given full coverage by the Annapolis Capital, including a front page headline article, and has been given careful attention by our District 5 County Council member (and now Chairperson of the County Council) Cathy Vitale. Cathy has reviewed the subdivision proposal and the provisions of the County Code and the Maryland Condominium Act with both the developer and the newly appointed Anne Arundel Director of Planning and Zoning, Joe Rutter. Cathy fully understands and supports our position and has made it clear to the developer and the County that Manhattan Beach intends to take the case to the County Board of Appeals and the County Court, if necessary. Cathy shares my belief that we would win in court.

I have made presentations on the Sonneborn Subdivision issue to the Greater Severna Park Council (representing 65 community associations), the Broadneck Federation (representing 39,000 residences) and the Arnold Preservation Society to enlist their support in our battle against the proposed development. I have also discussed it separately with the heads of three other Anne Arundel County community organizations. I have made it clear to all that while the current development proposal affects only Manhattan Beach, it will adversely and severely affect every community in Anne Arundel County if the County Executive allows the developer to proceed as proposed and Manhattan Beach were to lose its case. If that happens, maximum density development will be here to stay.

There is some hope that the new Director of Planning and Zoning, who is currently making a careful study of subdivision and zoning codes, will come to the understanding that Anne Arundel County Code does not support what the developer proposes. Stay tuned.



I feel strongly that this right of way to the water should remain under the control of the residents of Manhattan Beach for the possible future development.
