## Bylaws Change Vote at April Meeting


Puxatauney Phil is to be believed we still have another month of winter, but I'm sure that, like me, most of you are eagerly anticipating spring.

The MBCA Board has been very busy this winter drafting a proposed change to the Bylaws. After the vote last fall on the proposed tax increase, it was clear that votes on important issues should be better organized, more easily verified, and, if possible, more representative. To those ends a proposed amendment to the Bylaws is printed in this newsletter. The changes in the Bylaws would allow a written ballot to be sent with the announcement of an important vote. The ballot could then be returned by mail before the next meeting or submitted person at the meeting the votes are tallied ballot would be print opposite the preprinted label the county provides to the community for every tax account, so it would be easily validated. If a ballot were lost a replacement ballot would be available at the meeting that could be validated later. The ballots would serve as a verifiable record of the vote. Every

eligible member of the community would have an opportunity to cast their ballot. One disadvantage of this system would be that people who cast their vote by mail would not have an opportunity to hear and participate in the discussion before the vote. It would be incumbent upon those voters to talk with their neighbors while forming their opinion.

Perhaps many of you read the recent article in The Capital about the difficulties another special tax district had with proxy votes. One member collected a number of proxies and wielded undue influence over the community. Our Bylaws do not presently allow proxy votes and that would not change. Each eligible voter would cast his or her own vote either by mail or in person at the meeting.

According to the existing Bylaws, the members present at the next meeting at least 30 days after this notice will vote on this amendment. I urge you to give this proposal serious consideration. The text of the bylaws, showing both current and proposed language is found on page 7 of this newsletter.



## Tree Cutting in Manhattan Beach

Manhattan Beach in its entirety is located within the critical area of the Chesapeake Bay. All of our community lies within the 1000-foot boundary and is subject to the laws regarding tree removal. Please call first to get permission from the county forester before you remove a tree in your yard. Some residents have cut trees without approval and have had stiff fines levied


against them. Reputable tree removal companies will not remove trees unless you can show that you have the authorization to do so. Planting trees and other natural vegetation is the most effective means of retaining soil from your yard and prevent it from washing into our creeks. Examine your yard to see what you can do to prevent erosion and help improve the health of our creeks in the process







# Bylaws Change

## ARTICLE XII - VOTING PROCEDURES

There shall be no proxy voting. There shall be one vote per tax account. Multiple tax account owners have one vote for each tax account property. A majority of members present shall carry any motion, unless otherwise provided for in these bylaws Bylaws. A quorum, as defined in Article XIII, must be present at the time of the vote at both membership and Board meetings. A written ballot shall be required for (1) any proposed amendment to the MBCA Bylaws, (2) any proposed sale, purchase or trade of real property and (3) any proposed increase or decrease in the annual assessment per tax account. The Secretary shall mail the the ballot to the entire membership no later than 30 days prior to a general meeting at which the vote is scheduled to be tallied. Completed ballots may be returned to the MBCA post office box postmarked no later than 5 days prior to said general meeting or individual members may present their completed ballots in person at the meeting prior to the count. Vote results shall be announced at the general meeting if available and published in the MBCA Newsletter

## ARTICLE IV - Dues and Special Tax Benefit District

A. There are no dues payable by any member of MBCA while the Tax Benefit District provides funds to the Manhattan Beach Civic Association.

B. The following rules apply to the receipt of any funds by MBCA from the special benefit tax district:

1. The Board shall recommend, and the membership vote, on the amount to be taxed per tax account and the budget of monies received;
2. A 50% rebate will be provided by the MBCA to any member 65 years or older upon written request within the fiscal year for which the rebate is sought. Provided, that the Board shall first determine if sufficient funds are available to fund this rebate.
3. At least 90 days before the date that the MBCA budget for Special Benefit Tax District funds must be submitted to Anne Arundel County, the Board may propose a maximum limit on the amount of tax per tax account. If the Board proposes to increase the maximum limit above \$25.00 per tax account, the Board must notify the membership by mailing a written notice at least 60 days prior to the date for the submission of the budget to the county and at least 30 days prior to the general meeting when the votes will be counted. The notice must specify the maximum limit proposed and the reasons for the increase above the maximum limit of \$25.00 per tax account. The maximum limit will not be increased unless a majority of the members present at a scheduled meeting, with written notice of the meeting post marked to all tax accounts at least 30 days before the meeting, votes in favor of the increase. .

4. The proposed budget for the use of the funds that arise from the tax benefit district shall be submitted to the membership at the same meeting described in Section B.3, Article IV., or at another meeting. Provided that the proposed budget shall be submitted to the membership and approved by a majority of the members ~~present at a meeting~~, with written notice (including the proposed budget) of the meeting postmarked to all tax accounts at least 30 days before the meeting.

## ARTICLE X

A. The community association shall have the right to buy, trade and sell non-real estate or to enter into service contracts. . No non-real estate property valued at more than ~~No~~ non-real estate property valued at more than One Hundred Dollars (\$100.00) will be purchased without a majority vote by Board of Directors. Any property valued at more than One Thousand Dollars (\$1,000.00) shall not be purchased, traded or sold without majority vote at a meeting of the membership. No service contract for more than Two Thousand Dollars (\$2,000.00), to be paid in less than one year can be authorized by the Board without three written competitive bids

B. Provided, that if the Board determines that community emergency exists and that insufficient time exists to obtain membership approval, the Board may authorize, by a two-thirds vote, the expenditure of sufficient funds to address the community emergency situation.

C. The community association shall have the right to buy, trade and sell real estate. The Board of Directors shall determine by majority vote any real estate that may be considered for sale, purchase, or trade. If the Board approves the proposed sale, purchase or trade, then the transaction must be approved by ~~an affirmative~~ a majority vote of the association members ~~present at two consecutive regular meetings~~. The details of the proposed transaction will be mailed to the association membership with a postmark of at least ~~thirty~~ 30 days prior to the first vote. In the event of a vote against a proposed transaction, the purchase, trade or sale of that property may not be voted upon again for one year



## ARTICLE XV - AMENDMENTS

The Constitution and Bylaws may be amended by a two-thirds vote of the membership ~~present at any regularly scheduled meeting of the Association, or specially set meeting of the Association. Provided, however, notice of any proposed change in the constitution or bylaws is mailed with a postmark at least thirty days in advance of the date of the date set for the vote on the proposed amendments.~~
